- Leads the charge for Optimal Team Practice

Submission guidelines

Please submit a nomination letter that describes the candidate using the following guidelines.

Include narrative in the letter that describes the nominee using the following guidelines as it relates to the <u>PA</u> <u>profession and practice</u>.

- Tell us how this professional is recognized as an advocate for the PA profession
- How has the nominee made a lifelong contribution to the PA profession, colleagues and to health systems?
- How has the nominee advocated for PA students and the CWRU PA program?
- How does the nominee advocate at the state, national, and local level? Provide examples.
- How does the nominee lead change to promote optimal team practice?

Include narrative in the letter that describes the nominee using the following guidelines as it relates to the <u>community</u>.

- How has the nominee furthered the image of the physician assistant profession to the community?
- Does the nominee hold memberships and is active in the State and National PA societies?
- Any additional humanitarian services?
- Describe the characteristics and qualities the nominee possesses that makes him/her an exemplar and provide examples.

Summary of required documents for submission

- Nomination letter with name and contact information of person/s providing recommendation
- Two narratives required on nominee's contributions related to the <u>PA profession and practice</u> and the <u>community</u>.
- Recent curriculum vitae of the candidate with current contact information
- Additional reference letters and documentation to support nomination (strongly recommended)
